Community Committee Report:

This was presented by Cllr David Fall:

- Defib –good attendance at training. 30 attended. System required to check that it is working, Carol Parsons to be asked to check on a Sunday.
- War Memorial 1st May target date to meet the Queens birthday celebrations. Stones are being sourced this
 weekend.
- Speed Limits indicator device, WCC have withdrawn them all. PO inquired about them and we are now the
 owner of one (3k). To be shared with Burbage, Easton Royal and East Grafton. Batteries to be purchased and PO
 and RJ to attend a training course. PO writing to other councils to invite them to partake if they are prepared to
 meet criteria. Install at crossroads weeks 1 and 2 of a month and at Little Salisbury weeks 3 and 4. The Street to
 be considered as a location too. Hoping to trial asap.
- Community Speedwatch awaiting on WWC to lay the wires to be put down before attendance of the course.
 20 mph within village to be proposed at AGM. Only 2 applications per year. Financial contribution required from PCCs. (Easton Royal spent 2k). We will use the indicator first to gauge average speeds before moving forward. PO to speak with Mark Stansby at WCC.
- Traffic calming gates £1600 potential cost. To be discussed after we have some results from indicator.
- Footpaths One Bridleway currently blocked by stiles. PO has spoken to chairman of Pewsey PCC.
- Gerald has undertaken to clear brambles form Clay Lane & ?. Request to improve surface of Clay Lane, like the
 paths in Easton Royal using old road chippings. Agreement to take to AGM.
- Some signage is to be updated/replaced.

- Everleigh Recycling Centre special meeting took place and after and recalculation of some figures and public pressure it will now remain open.
- Emergency planning templates received. Community committee to make a start on pulling it together.
- Subcommittee Would like to recommend we enter the Best Kept Village competition. PO suggests using flags again to make an impact.
- Speed Gates & Competition proposed by David, seconded by Ann, all agree.

Chairman's Notices:

- VHC PO has stepped down after 23 years. A new representative member will be required.
- 90th birthday celebrations 11/12 June weekend. Hog Roast/Children's Tea Party/ Opening of War Memorial/fireworks all suggestions. Commemorative bench on top of Milton Hill suggested, Gerald to be asked. DF proposed, unanimous support.
- Chairman's Notice PO intends to stand as chairman again, wanted to canvass opinion if this is acceptable. It was
 deemed acceptable.
- Role of chairman/clerk/vice chair are becoming more challenging. Vice chair will need to be filled as Serena will be stepping down after a long tenure!
- PO voiced that Ray Edwards was interested in joining the Council. Rachel? from New Mill also suggested.
 There is the suggestion that we might want someone who has lived here a little longer or from The Severalls.
 Agreed that position to be advertised to seek applicants before anyone else added.
- WCC taking over grass contract.
- PO proposes an increase to RJ salary by £100. All agreed. Members would like to see the agenda/minutes on the boards more promptly.
- AGM Date Sometime in April/May. PO will work on dates.

Councillors Questions Time:

• Scrap yard – seems unsafe, and scrap is falling onto neighbouring land. A Health & safety issue? RJ to action.
